- Epwe eukatiw tobacco vaping epwe mecheres: Epwe efista 65% takisesin nicotine nupwen epwe amomo seni chon amomo me mwan epwe tou ngeni aramas. Epwe keran iei ewin takises epwe pwan ekukunano an neuch sérafo repwe umwesiti.
